## **MARSHALL COUNTY PARK RULES**

**CAMPERS WHO VIOLATE PROCEDURES WILL BE ASK TO LEAVE THE PARK.**

1. **SPEED LIMIT IS 5 MPH – STRICTLY ENFORCED**
2. **RECREATION VEHICLES ONLY (RV'S MUST HAVE CURRENT TAGS & MEET ELECTRICAL, SEWER, AND APPEARANCE CODES)**
3. **MOTORCYCLES (EXCEPT FOR THE TRANSPORTATION IN /OUT OF PARK), MOTORBIKES, ATV'S, GO-CARTS, ETC. WILL BE NOT ALLOWED ON PARK PROPERTY FOR THE SAFETY OF OUR GUESTS.**
4. **RESPECT YOUR NEIGHBORS; QUIET TIME WILL BE OBSERVED FROM**  
10:00 P.M. UNTIL 8:00 A.M. MONDAY- THURSDAY  
11:00 P.M. UNTIL 8:00 A.M. FRIDAY- SUNDAY  
\*ALL VISITORS MUST BE GONE BEFORE QUIET TIME BEGINS.  
\*CAMPERS MUST MEET THEIR VISITORS AT GATE.
5. **NO ANIMALS, GLASS CONTAINERS FOOD OR BICYCLES ALLOWED ON PIER OR PLAYGROUND. BE RESPECTFUL OF OTHER GUESTS.**
6. **FIREWORKS WILL ONLY BE PERMITTED ON JULY 4<sup>TH</sup> UNTIL 11:00 IN DESIGNATED AREAS. AN ADULT MUST ACCOMPANY ALL CHILDREN.**
7. **PETS MUST BE ON A LEASH AT ALL TIMES. PET OWNERS MUST CLEAN-UP ANIMAL WASTE.**
8. **ABSOLUTELY NO FIREARMS WILL BE ALLOWED IN PARK.**
9. **EACH CAMPER IS RESPONSIBLE FOR KEEPING CAMPSITE CLEAN, INCLUDING CARRYING TRASH TO DUMPSTER. WE MUST BE ABLE TO MOW CAMPSITE. NO MAKE SHIFT FIRE PITS ALLOWED. CIGARETTE BUTTS DO NOT GO ON THE GROUND.**
10. **SWIMMING WILL BE AT YOUR OWN RISK; THERE WILL BE NO LIFEGUARD ON DUTY.**
11. **THERE WILL BE NO DIVING FROM THE PIERS.**
12. **BOATS, BOAT TRAILERS AND JET SKIS MUST BE STORED IN DESIGNATED AREA.**
13. **THERE WILL BE A \$35.00 CHARGE ON ALL RETURNED CHECKS.**
14. **IF A GUEST IS RENTING BY THE MONTH AND LEAVES EARLY, THEY WILL BE RESPONSIBLE FOR THE ENTIRE RENT.**
15. **NO NAILS OR WIRES WILL BE PUT INTO TREES.**
16. **NO DISCHARGE FROM CAMPERS. IMMEDIATE DISMISSAL FOR VIOLATORS.**
17. **NO ALCOHOLIC BEVERAGES ALLOWED IN PUBLIC AREAS INSIDE THE CAMPGROUND (EX: PIER, BOAT LAUNCH, PLAYGROUND, PAVILION, ROADWAYS)**  
\*\* PUBLIC DRUNKENNESS OR FIGHTING WILL RESULT IN AUTOMATIC DISMISSAL FROM THE PARK.
18. **BIKE RIDERS MUST OBEY STATE LAWS AND CAMPGROUND RULES.**
19. **CHILDREN MUST BE ON CAMPSITE BY 10:00 P.M.**  
CHILDREN AT THE PLAYGROUND MUST BE ACCOMPANIED BY ADULTS AND FOLLOW PLAYGROUND RULES.
20. **THE MARSHALL COUNTY COMMISSION OR THE PARK WILL NOT BE RESPONSIBLE FOR THEFT OR ACCIDENT TO PERSONAL PROPERTY.**
21. **ANY ITEMS ABANDONED OVER 90 DAYS BECOMES PARK PROPERTY.**
22. **MANAGEMENT RESERVES THE RIGHT TO REFUSE TO SERVE ANYONE AT ANYTIME.**
23. **NO PRIVATE PIER OR OTHER STRUCTURES WILL BE ALLOWED IN THE WATER.**
24. **NO STRUCTURES WILL BE ALLOWED TO BE BUILT ON LOTS WITH THE EXCEPTION OF STEPS, WHICH REQUIRE PARK MANAGER OR COMMISSION APPROVAL.**
25. **KARAOKE WILL BE ALLOWED ONLY AT DESIGNATED TIMES AND PLACES.**
26. **TWO (2) VEHICLE LIMIT PER SITE. ONLY 1 BOAT OR 2 PWC PER SITE. ALL WATERCRAFT MUST BE REGISTERED IN GUESTS NAME.**
27. **ALL MAINTENANCE NEEDS MUST BE REPORTED TO PARK MANAGER. DO NOT ALTER ELECTRICAL OR WATER OUTLETS. CONNECTING MULTIPLE OUTLETS IS NOT ALLOWED. ALL UNITS ARE EQUIPPED WITH 30 AMP BREAKERS.**
28. **PARK RATES APPLY TO ONE FAMILY (MINORS, DEPENDENTS) ONE SELF-CONTAINED RV WITH ONLY ONE AIRCONDITIONER, GAS HOT WATER HEATER, GAS OVEN-RANGE AND ONE REFRIDGERATOR. Any eruptions to above may result in additional fees.**
  - **DAILY - \$26.00 ON WATER  
\$21.00 OFF WATER**
  - **MONTHLY- \$275.00 ON WATER  
\$225.00 OFF WATER**

- ALL FEES ARE PAID IN ADVANCE OF STAY. A \$25.00 LATE FEE WILL APPLY AFTER 10 DAYS.
- NO DELINQUENCY ALLOWED. ANY DELINQUENCIES BEYOND 30 DAYS WILL BE SUBJECT TO 1.5 % INTEREST.
- ANY CAMPER THAT BECOMES MORE THAN 30 DAYS DELINQUENT IN PAYING FEES, WILL BE REQUIRED TO REMOVE THEIR CAMPER FROM PARK AND PAY ALL FEES INCURRED.

**29. GATE CODE RULES**

- EACH CAMPSITE WILL BE ISSUED A SWIPE CARD FOR GATE ENTRY, WITH A MAXIMUM OF 2 PER CAMPSITE. ANY LOST CARDS MUST BE REPORTED IMMEDIATELY AND A \$10 CHARGE WILL BE REQUIRED TO REPLACE THE CARD. ALL CARDS MUST BE RETURNED TO PARK OFFICE AT THE END OF YOUR STAY, OTHERWISE YOU WILL BE CHARGED A \$10 FEE PER CARD BEFORE RE-ENTRY.
- ALL CAMPERS ARE RESPONSIBLE FOR ANY VISITOR/GUEST AT THEIR CAMPSITE.
- VISITORS/ GUESTS ARE TO STAY AT CAMPSITE WITH YOU.

**30. LENGTH OF STAY**

- DAILY- MAXIMUM OF 14 NIGHTS, AFTER TIME HAS PASSED CAPMER MUST LEAVE PARK OR CHANGE RENTAL TO MONTHLY LOT.
- MONTHLY- MAXIMUM OF 3 NIGHTS PER WEEK USAGE, PLUS 14 NIGHTS CONSISTENT STAY PER SEASON.
- MAXIMUM OF 6 PERSONS PER SITE. INVITED GUEST MAY ONLY BE PRESENT WHILE PAYING CAMPER IS PRESENT. ANY MORE THAN 6 PEOPLE MAY BE SUBJECT TO A \$2.00 PER NIGHT CHARGE.
- PARK WILL OPEN MARCH 1 – NOVEMBER 1.
- ALL RV'S WILL HAVE TO BE MOVED AND OUT OF PARK DURING THE PERIOD THE PARK IS CLOSED FOR WINTER MONTHS.

**31. BOAT RAMP AND DOCKS ARE FOR REGISTERED CAMPERS ONLY. BOATS MAY NOT BE PARKED OVERNIGHT IN WATER OR AT RAMP, UNLESS YOU ARE A REGISTERED CAMPER.**

**32. GOLF CARTS**

- GOLF CARTS ARE NOT TO BE DRIVEN BY ANYONE UNDER 16.
- GOLF CARTS ARE TO BE DRIVEN FROM POINT A TO POINT B AND NOT FOR JOY RIDING AROUND PARK.
- SPEED LIMIT IS 5MP WHEN DRIVING IN THE PARK.
- GOLF CARTS ARE TO BE PARKED AT CAMPSITE BY 10PM.
- AFTER DARK, GOLF CARTS MUST HAVE FRONT AND BACK LIGHTS TURNED ON.
- GOLF CARTS CAN ONLY BE DRIVEN ON CAMPGROUND ROADS. NO OFFROAD DRIVING.

**33. ALL CAMP SITES WILL BE REASSIGNED BEGINNING THE LAST TWO SATURDAYS IN FEBRUARY. SITES CANNOT BE RESERVED PRIOR TO THIS TIME. CAMP SITES WILL BE RESERVED ON A FIRST COME FIRST SERVE BASIS.**

*ANYONE REQUIRED TO LEAVE THE PARK FOR BREAKING THE ABOVE RULES, WILL NOT BE CONSIDERED FOR ENTRANCE TO CAMPGROUND FOR ATLEAST 12 MONTHS. I HAVE READ, UNDERSTOOD, AND WILL ABIDE BY ALL PARK RULES AND REGULATIONS.*
